



Copyright Agreement for Online Course Access

Effective Date: 13th August 2025

This Copyright Agreement (“Agreement”) governs the access and use of all course materials provided by Hannah Johnson Therapies (“Course Provider”), including but not limited to videos, text, images, slides, downloadable resources, and any other associated content (“Course Content”).

By accessing, purchasing, or viewing the Course Content, you (“User”) agree to the following terms:

1. Ownership & Copyright

All Course Content is the Intellectual Property of the Course Provider and is protected under copyright and Intellectual Property laws. All rights are reserved. No ownership rights are transferred to the User by this Agreement or through access or purchase.

2. Permitted Use

3. Prohibited Use

Without the prior written consent of the Course Provider, the User must not:
